SHORT FORM POWER OF ATTORNEY

WARNING TO PERSON EXECUTING THIS DOCUMENT-

This is an important legal document which is authorized by the general laws of this State. The powers granted by this document are broad and sweeping. They are defined in sections 18-16-1 to 18-16-12, both inclusive, of the general laws in chapter 18-5 entitled "Rhode Island Short Form Power of A Tommy Act."

The use of the short form power of attorney is strictly voluntary, and chapter 18-16 specifically authorizes the use of any other or different form of power of attorney upon mutual agreement of the parties concerned.

KNOW ALL MEN BY THESE PRESENTS, which are intended to constitute a **GENERAL POWER OF ATTORNEY pursuant to the Rhode Island Short Form Power of Attorney Act**:

THAT I,
